AN ORDINANCE ENACTING A NEW CHAPTER 12.05 IN THE CITY OF KLAWOCK CODE OF ORDINANCES ESTABLISHING A LOCAL REGULATORY AUTHORITY TO PROCESS APPLICATIONS SUBMITTED FOR REGISTRATION TO OPERATE A MARIJUANA ESTABLISHMENT WITHIN THE CITY, AND OTHERWISE REGULATING THE OPERATION AND LOCATION OF MARIJUANA ESTABLISHMENTS, MARIJUANA AND MARIJUANA PRODUCTS WITHIN THE CITY, AND PROHIBITING WITHIN THE CITY OF KLAWOCK (1) USE OR CONSUMPTION OF MARIJUANA IN PUBLIC, (2) USE, CONSUMPTION OR POSSESSION OF MARIJUANA BY PERSONS UNDER THE AGE OF 21, AND (3) THE FURNISHING OF MARIJUANA TO PERSONS UNDER THE AGE OF 21
